If the application exceeds this limit, the Applicant must divide the submission into multiple emails, ensuring that each email does not exceed 30 MB.</p> <p>Each email must be clearly identified and numbered in the subject line using the following format: "Application PQD 01-2024 – [Applicant’s Name] – Email [X] of [Total]"</p> <p>All emails must be received in full at the designated email address before the submission deadline. MCA-Kosovo will not accept late or incomplete submissions.</p>
